- Easy to listen to gave good explanations & examples.
- Eye contact was somewhat important as a social skill.
- Not understand how to teach social skills as well.
- Kids just picked up on this naturally.
- Social skills teaching was tough to transition mastery.
- Social skills curriculum is necessary.
- Teaching social skills is the most important thing.
- It wasn't possible to write succinct / measurable goals.
- Social & academic skills were more separate.
- Behavior relates to communication.

But now I know:

- Learned about MindWing.
- Help kids to feel success while learning. Focus on progress.
- That it could be that they are stuck on something they don't understand.
- "Social" is integrated heavily into every part of our lives.
- ILAUGH is more of a framework / theory of social thinking.
- Social thinking is all behavior, emotions, and communications and all the hidden rules that go with it.
- Eye contact how to work on it great suggestions other than look at me – teach what eye contact actually is.
- We need to make adjustments in our social skills.
- Eye contact is very important because we think with our eyes.
- The use of eyes, properly interrupt.
- Teach skills explicitly.
- Good skills to integrate into the day.
- It is necessary, but we need to teach the "think" part first.
- There is so much more than that.
- Better ways to write & measure goals.
- I have more to learn.
- They are completely intertwined & dependent.
- Behavior <u>is</u> communication. I really appreciated the "root level" functioning that better explained behaviors exhibit by students. Take home strategies to directly apply to my students.
- Social and academic go together.

Social was taught separate.

- Social thinking didn't affect the other aspects of their learning.
- Social thinking involved a more finite number of skills.
- I have no idea how to handle conversations with some of my students.
- Eye contact wasn't important.
- Didn't know ILAUGH.
- Realized how hard initiating can be for some students.
- That you begin by working on communication skills.
- I didn't know ILAUGH
- Eye contact was mostly for eye to eye.
- Social language goals are to write / measure.
- That eye contact and knowing where are eyes are and what we are thinking is important.
- Kids should just know most social cues & rules.
- You taught the "leaves" from the social learning tree first.
- Kids give up / don't try at times.
- I knew that some students didn't understand some social situations / concept & had to be taught them explicitly not always sure how to go about it.
- Eye contact

- I now know that everything is connected.
- Expanded understanding of the broad scope of skills involved in social competencies.
- I have resources that I can try out with them.
- We take this info for granted.
- Eye contact is essential.
- What ILAUGH is.
- Helpful solutions to encourage students to start conversations.
- That you start by understanding the thinking that goes into communication.
- ILAUGH
- Teaching the technique of "where" eyes are truly looking to individuals with social communication difficulties.
- There are many good examples in this packet.
- But now I know that this is a very important social skill and should be practiced.
- They need to be taught.
- You need to start w/ the roots of the tree first.
- Making students aware of their thinking is good.
- All kids want to be successful, but they get stuck.
- To ask & understand their thinking & where we are starting from. It may be the very early concepts they haven't developed.
- I did not realize how important social issues are connected to academic areas.
