Medicaid



NESC bills Medicaid for OT, PT, and SLP services given to a student with Medicaid. This is an important program – not just in the short term as a source of revenue (bringing over \$30k of revenue in calendar year 2024) but also in the long term because districts applying for extraordinary cost funds are asked whether they have exhausted all available sources of revenue, including Medicaid billing.

OT, PT, and SLP Providers: As you attend IEP meetings for children you'll serve, please ask whether these children have a Medicaid number. If they do, please ask parents to complete the [consent to bill Medicaid](#) form (which should include the child's Medicaid number, the parent's signature, and where the child is doctoring). Director Message

Where does NESC get it's Money?

Have you ever wondered where NESC gets the money it uses to run our operation? Unlike school districts, our cooperative does not generate state revenue based on enrolled students.

NESC is funded primarily through federal and state special education funds. The NESC districts have signed an agreement to allow NESC to be the fiscal agent for those funds and those funds pay for your salary, benefits and other costs.

Any costs that are unable to be covered by federal and state funds are taken care of through assessments to our member districts. Each district is assessed a percentage based on their enrollment/child count numbers.

When NESC raises costs for any service or for any new service, it almost guarantees that those costs will be directly passed along to our districts.

As the next legislative session looms in the distance, South Dakota is facing a revenue shortfall. People in South Dakota are just not spending money at the same rate as we have in the past. Our sales tax and property taxes are the two main ways that our state generates funds to pay for public services, like education.

Despite a law that requires the state to provide school districts with funding that equals the rate of inflation or 3%, which ever is less, we were given a 1.5% increase last year. Some are concerned that we could see a funding freeze or cut this year. These cuts and freezes will cause pain to our member districts, particularly our smallest districts.

There are always opportunities that come from tough times and adversity. If you are not attune to what happens out our state legislative level, this year may be a good time to pay attention.

Sped Forms



Earlier this month, student information was uploaded from information from Infinite Campus into Sped Forms. Each student was assigned a resident district and was given a fake case manager. The district Sped Forms administrator should have then assigned students to the correct Plan Manager in the district.

To gain access to students for whom you see, the Plan Manager, District Sped Forms Admin or Tim, Anneke or Brenda can give you access to that student. You can obtain edit access, that allows you to edit documents or view access which allows you to see documents but not edit them.

Because the information that was uploaded into sped forms may have contained errors, Plan Managers will need to check the demographic information to ensure that it is accurate.

When writing IEPs, the Plan Manager will need to "Validate" the IEP in order to enable printing. The validation ensures that all areas of the IEP have been addressed. In some areas, such as accommodations or state testing, if items are not checked or if text is left blank, the program assumes it has not been addressed. One must address all areas on the IEP to validate.

If you have fake students that need to be deleted, please send Tim Frewing the name and he can delete them from the NESC list of students.

All new evaluations should be written in Sped Forms. All providers will use Sped Forms to create one report that will be given to parents.
